Summary of Investment Objective

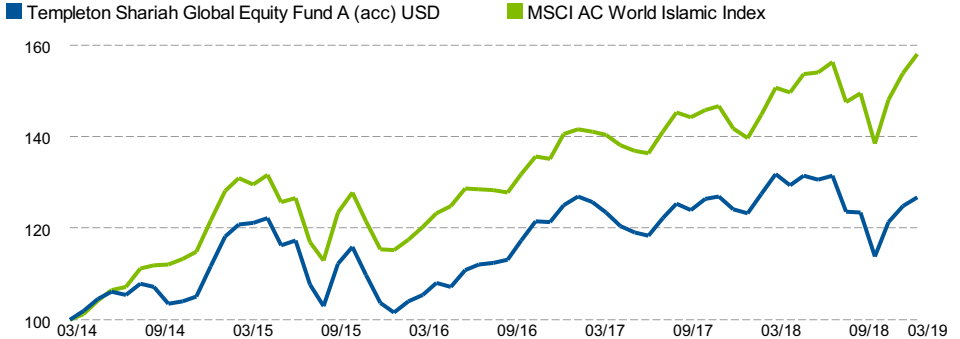
